The Humanities

In the act that established the National Endowment for the Humanities, the term *humanities* includes, but is not limited to, the study of the following disciplines: history; philosophy; languages; linguistics; literature; archaeology; jurisprudence; the history, theory, and criticism of the arts; ethics; comparative religion; and those aspects of the social sciences that employ historical or philosophical approaches.

NEH Summer Stipends

NEH Summer Stipends provide support for faculty members of universities and of two-year and four-year colleges and for other persons working in the humanities so that they can devote two consecutive months of full-time study and research to their projects. An applicant's project may be one that can be completed during the stipend tenure, or it may be part of a long-range endeavor.

Projects supported by NEH Summer Stipends contribute to scholarly knowledge, to the conception and substance of individual courses in the humanities, or to the general public's understanding of the humanities. Projects may address broad topics or consist of study and research in a specialized field.

Eligibility

Applicants should be U.S. citizens, native residents of U.S. territorial possessions, or foreign nationals who have lived continuously in the United States or its territories since October 1, 1984.

Applicants for NEH Summer Stipends need not have advanced degrees, but neither candidates for degrees nor persons seeking support for work toward a degree are eligible to apply.

A person who has received a major fellowship or research grant for the 1985-86 academic year or for subsequent academic years is *not* eligible to apply. Sabbaticals or grants from a scholar's own institution are *not* considered major fellowships, nor are other summer research stipends or grants supporting scholarly work during the academic recess.

Persons who have held NEH Summer Stipends in 1984 or later are not eligible to apply for 1988 awards.

Nomination

Each college and university in the United States and its territorial possessions may nominate three members of its faculty for the Summer Stipends competition. No more than two of the nominees may be in the early stages of their careers, that is, *junior* nominees; no more than two may be at a more advanced stage, that is, *senior* nominees. Thus, when an institution selects three nominees for the Summer Stipends competition, two may be *junior* and one *senior*, or one *junior* and two *senior*.

For the purposes of the Summer Stipends Program, academic applicants who hold the rank of instructor or assistant professor or who are at comparably early stages of their careers will be considered *junior* nominees. Those holding the rank of associate professor or professor will be considered *senior* nominees.

Applicants on temporary leave from their home institutions (for example, those with sabbaticals, visiting professorships, etc.) must be nominated by their home institutions.

Nonfaculty college and university staff members are eligible for the Summer Stipends Program. Such persons may apply without nomination, provided that they will not be teaching during the 1987-88 academic year.

Academic applicants with appointments terminating by the summer of 1988 and others not employed by colleges and universities are exempt from nomination and may apply directly to the Endowment.
