LEGISLATIVE HISTORY OF THE NATIONAL FOUNDATION ON THE ARTS AND HUMANITIES. 89TH CONGRESS-92ND CONGRESS

September 15, 1971

Highlights of Proposals and Activities Expanding Federal Interest in the Arts and Humanities prior to the establishment of the National Foundation on the Arts and Humanities.

1953--The Commission of Fine Arts, at the request of President Truman, issued a report on "Art and Government" recommending the use of federal funds to purchase American art for the National Collection of Fine Art (a part of the Smithsonian) and to assist public high schools in acquiring equipment for teaching the arts.

1955--President Eisenhower proposed that Congress establish a Federal Advisory Commission on the Arts under HEW, but no such legislation was enacted during the Eisenhower Administration.

1958--Congress passed a bill to construct a National Cultural Center in the District of Columbia. The bill donated federal land, but construction funds were to be raised from private contributions. In 1963 the law was amended to authorize matching federal contributions for construction of the center, renamed for President Kennedy.

1961--President Kennedy backed legislation to establish a Federal Council on the Arts. It was rejected by a 166-173 roll call vote in the House.

1961--Secretary of Labor Goldberg, after arbitrating a N.Y. Metropolitan Opera Assn. labor dispute, issued a report Dec. 14 on "The State of the Performing Arts," in which he urged aid to the performing arts "as a new community responsibility." He supported the proposal for a Federal Advisory Council on the Arts and recommended tax concessions, federal scholarships, and housing and custodial aid by local and state governments for opera and symphony companies.

March 1962--President Kennedy appointed August Heckscher as Special Consultant on the Arts. Heckscher May 28, 1963, issued a report. "The Arts and the National Government," recommending establishment of a National Arts Foundation "on the model of the existing foundations in science and health" to provide the focus for federal efforts to stimulate the arts.

1963--Mr. Kennedy issued an Executive Order creating the President's Advisory Council on the Arts. (However, the Council was never activated.) In the same year, the Senate passed a Kennedy Bill (S2379) establishing a National Council on Arts and a National Arts Foundation to make matching federal grants to the states and non-profit professional groups to encourage and support the arts. S2379 authorized appropriations of \$5 million for grants in the first year and \$10 million each year thereafter.

1964--The Office of Education added a separate Cultural Affairs Branch to give increased attention to the arts and humanities.

1964--Congress passed the National Arts and Cultural Development Act

establishing a National Council on the Arts in the Executive Office of the President. The Council's role was to be advisory, not to subsidize the arts.

1964--In a Sept. 18 speech at Brown University, President Johnson said, "I look forward with greatest favor on the proposal for a national foundation on the humanities."

The President's speech at Brown followed the issuance of a report by the National Commission on the Humanicies. The Commission was established jointly in 1963 by the American Council of Learned Societies, the United Chapters of Phi Beta Kappa and the Council of Graduate Schools in the United States. In its 1964 report, it called for the establishment of a National Humanities Foundation to support study, teaching and research in the arts and humanities through federal grants and fellowships and through assistance in construction and expansion of libraries, classrooms, etc.. The report said that the United States faced a "crises of national leadership" because the development of the humanities lagged far behind science and technology.

CONGRESSIONAL DEBATES ON THE NATIONAL FOUNDATION ON THE ARTS AND THE HUMANITIES

1965--89th Congress, 1st Session

National Foundation on the Arts and the Humanities Act (P.L. 89-209)

June 10, 1965--Senate passed S. 1483 to establish a National Foundation on the Arts and the Humanities. (Pages 13103-13111)

Sept. 29, 1969--PL 89-209 signed into law.

Major provisions of the law:

1. Authorized establishment of National Foundation on the Arts and Humanities composed of a National Endowment for the Humanities and a Federal Council on the Arts and Humanities.

2. Specified that the purpose of the Foundation was to "promote a broadly conceived national policy of support for the humanities and arts in the United States."

3. Prohibited any federal employee or agency from directing, controlling, or supervising the policy or administration of any school or other non-federal agency, institution or organization.

Arts Endowment

1. Broadly defined "arts."

2. Transferred the existing National Council on the Arts (PL 88-579)

from the Executive Office of the President to the Arts Endowment to advise the Chairman of the Arts Endowment, review applications for federal arts funds and make recommendations about the applications. Increased membership from 24 to 26 members.

3. Authorized the making of matching grants to individuals and groups for use in production, projects, workshops, and other relevant projects, including surveys, research, and planning in the arts. Such grants were limited to one-half the total cost. Up to 20% of the funds allotted for such purposes could be used for full cost grants where matching funds were not available.

4. Authorized the chairman to accept donations and gifts to the Endowment. Authorized appropriations of up to \$2,250,000 during any fiscal year to match donations to the Endowment.

5. Authorized appropriations of \$5 million annually to the Arts Endowment during fiscal 1966-1968 for grants to groups and individuals.

6. Authorized continuing annual State Aid Programs allotting \$50,000 to States, possessions and the District of Columbia having state agencies to aid the arts.

Humanities Endowment

1. Broadly defined "humanities."

2. Authorized establishment of a National Council on the Humanities having 26 members plus the chairman of the Humanities Endowment as Council Chairman; to advise the chairman, review applications for funds and make recommendations on the applications.

3. Authorized the chairman to: a) develop and encourage a national policy to promote progress and scholarship in the humanities, b) Initiate

and support research and programs to strengthen the "research potential" of the United States through financial assistance, c) Award fellowships and grants to institutions and individuals for training and workshops in the humanities. d) Foster the interchange of information in the humanities, e) Foster public understanding and appreciation of the humanities. f) Support the publication of scholarly works in the humanities.

4. Limited grants to workshop activities which charged admission to the general public to 30% of the total cost of such activities.

5. Authorized the chairman to accept gifts and donations to the Endowment. Authorized annual appropriations of up to \$5 million to match such donations.

6. Authorized appropriations of \$5 million annually to the Humanities Endowment during fiscal 1966-1968 for financial assistance for the humanities.

Federal Council on the Arts and Humanities

1. Established in the Foundation a Federal Council on the Arts and Humanities to advise the chairmen of the two endowments, to coordinate the activities of the two endowments, to coordinate the programs of the Foundation with other related federal programs and to plan participation in "major and historic national event."

2. Provided that the Council would have the following members: the Chairmen of the two endowments, the U.S. Commissioner of Education, the secretary of the Smithsonian Institution, the director of National Science Foundation, the Librarian of Congress, the Director of the National Gallery of Art, the Chairman of the Commission of Fine Arts and one member designated by the Secretary of State. Supplemental Appropriation Act of 1966 (P.L 89-309)
