The code establishes certain standards of conduct in research, publication, and public programs involving Native American peoples.

Equal Opportunity

The Code of Federal Regulations, Title 45, Part 1110 implements provisions of Title VI of the Civil Rights Act of 1964, and, along with Title IX of the Education Amendments of 1972, Section 504 of the Rehabilitation Act of 1973, and the Age Discrimination Act of 1975, provides that the National Endowment for the Humanities is responsible for insuring compliance with and enforcement of public laws prohibiting discrimination because of race, color, national origin, sex.

handicap, and age in programs and activities receiving Federal assistance from the National Endowment for the Humanities.

The National Endowment for the Humanities

The National Endowment for the Humanities is an independent grant-making agency established by Congress in 1965 to support research, education, and public projects in the humanities.

The Endowment supports work in the humanities through programs administered by its five

divisions — Fellowships and Seminars, Research Programs, Education Programs, General Programs, State Programs — and two offices — the Office of Challenge Grants, and the Office of Program and Policy Studies.

The Humanities

According to the act that established the Endowment, the humanities include, but are not limited to, the study of history; philosophy; languages; linguistics; literature; archaeology; jurisprudence; the history, theory, and criticism of the arts; ethics; comparative religion; and those aspects of the social sciences that employ historical or philosophical approaches.

Work in the creative or performing arts—such as writing of fiction or poetry, painting, sculpture, musical composition or performance, acting, directing, and dance—is not eligible for support by the National Endowment for the Humanities.

Persons interested in support in these areas should address the National Endowment for the Arts. Critical, historical, and theoretical studies of the arts, however, are eligible for support at the National Endowment for the Humanities.

Those undertaking studies in the social and natural sciences that are historical or philosophical in approach, or that attempt to cast light on questions of interpretation or criticism traditionally in the humanities, are eligible and encouraged to apply to the programs of the National Endowment for the Humanities.

Endowment Fellowships

Through its fellowships programs, NEH encourages and supports advanced study and research in disciplines of the humanities by people of diverse interests, backgrounds, and circumstances: senior scholars; junior scholars; writers and scholars working in the humanities either independently or in other than academic institutions; faculty members at institutions with extensive Ph.D. programs in the humanities; faculty members in two-year, four-year, and five-year colleges and universities.

Projects supported by Endowment Fellowships may contribute to scholarly knowledge, to the conception and substance of individual courses in the humanities, or to the general public's understanding of the humanities. Projects may espouse a broad interpretive intention, or consist of study and research in a specialized field. Fellows may pursue study and research within their own areas of competence and interest or in some other area that will enable them to understand their own fields better, to extend their competence, or to become more broadly informed.

Two Endowment divisions support scholarly research: the Division of Fellowships and Seminars, and the Division of Research Programs. Normally, applications for support of individual study and research should be submitted to the Division of Fellowships and Seminars, and applications involving the collaboration of two or more scholars should be submitted to the Division of Research Programs. However, there are some exceptional types of individual projects for which applications might more appropriately be submitted to the Division of Research Programs:

The production of reference works and scholarly tools, such as bibliographies, certain editing projects and translations, dictionaries, atlases, and encyclopedias;

- 2) Any aspect of archaeological scholarship;
- 3) Projects with large research costs other than salary support and travel, such as computer costs, salaries of assistants, consultants, travel costs, and equipment costs; and
- 4) Circumstances where the *only* subvention needed is for travel costs to special collections containing materials critical to a project.

All other individual projects of study and research in the humanities should be submitted to the Division of Fellowships and Seminars. For applicants unsure about which Endowment division should receive an application, early consultation with Endowment staff will establish to which division an application should appropriately be submitted.

Problems pertinent to the humanities content of an applicant's own teaching field are an appropriate part of fellowship study. However, applications for surveys of courses and programs in other institutions and for the preparation of institutional curricula are not. Inquiries about the possibility of Endowment support for projects to improve curricula or teaching of the humanities should be directed to the Endowment's Division of Education Programs. Also ineligible for Endowment Fellowships are applications to improve the methods of courses, to carry out empirical educational research projects, or to examine theories of teaching and learning that lack content in a discipline of the humanities.

NEH Fellowship Programs

Fellowships offered through the Endowment's Division of Fellowships and Seminars provide support for independent advanced study and research in the humanities. They free Fellows from the day-to-day responsibilities of teaching and other work for extended periods of uninterrupted investigation, reflection, and often writing.

The NEH fellowship programs serve different groups of scholars. Individuals teaching in undergraduate colleges and universities should consider applying to the program of Fellowships for College Teachers. Individuals teaching at universities with extensive Ph.D. programs in the humanities and scholars and writers working independently or in institutions outside academia should apply to the program of Fellowships for Independent Study and Research.

In observation of the 200th anniversary of the U.S. Constitution, the Endowment has established a special competition — in conjunction with its regular fellowship programs — for Constitutional Fellowships to encourage studies covering the range of philosophical and historical questions raised by the Constitution and the founding period. Because applications for Constitutional projects will be considered within the regular programs, individuals should apply through either the program of Fellowships for College Teachers or the program of Fellowships for Independent Study and Research, depending upon their institutional affiliation or circumstances.

Fellowships for College Teachers.

These fellowships provide opportunities for college teachers to pursue independent study and research that will enhance their capacities as teachers, scholars, and interpreters of the humanities and that will enable them to make significant contributions to thought and knowledge in the humanities. This program is predicated upon an equal respect for study and research directed toward scholarly publication and for study and research directed toward teaching. It is designed to support both beginning and experienced scholars

and teachers who are engaged in a range of activities from general study to specialized research. These fellowships are intended for teachers whose day-to-day responsibilities lie in the teaching of undergraduate students, particularly in two-year, four-year, and five-year colleges and in universities that do not have Ph.D. programs. Prospective applicants teaching in such institutions are encouraged to apply for fellowship support through this program even if the interests of their proposed projects are distinct from their teaching interests.

Fellowships for Independent Study and Research.

These fellowships provide opportunities for individuals to pursue independent study and research that will enhance their capacities as teachers, scholars, or interpreters of the humanities and that will enable them to make significant contributions to thought and knowledge in the humanities. This program is designed to support persons who have made significant contributions to the humanities as well as those who stand at the beginning of their careers. Projects may cover a range of activities from general study to specialized research. These fellowships are intended both for individuals affiliated with academic institutions, primarily those with extensive Ph.D. programs in the humanities, and for scholars and writers working independently or outside academic institutions.

Constitutional Fellowships.

These fellowships provide opportunities for individuals to pursue study and research on the philosophical, literary, historical, or political origins of the Constitution; the relation of the structure of the Constitution to American political, social, or intellectual culture; or the connection between self-government and the purposes of human life. Proposals may address the history of the founding period, constitutional principles, comparative constitutional government, individual rights, the character of democracy, American federalism,

American political institutions, constitutional interpretation, or any other topic that would be appropriate to the observation of the Bicentennial of the U.S. Constitution. Applications for Constitutional Fellowships may come from faculty members of colleges and universities as well as from writers and scholars working outside academia. These applications should be submitted in conjunction with either the program of Fellowships for College Teachers or the program of Fellowships for Independent Study and Research. The program under which applicants apply depends upon their institutional affiliation or circumstances, and applicants should follow the guidelines and instructions for the appropriate program.

No person may apply in the same year to more than one of the three programs of Fellowships for College Teachers, Fellowships for Independent Study and Research, and Constitutional Fellowships. An individual may apply for one type of fellowship at the same time he or she applies for other programs within the Endowment but may not hold more than one award from the Division of Fellowships and Seminars in any given year.

Criteria for Selection

Fellows in the programs of Fellowships for College Teachers, Fellowships for Independent Study and Research, and Constitutional Fellowships will be selected on the basis of the following criteria and guidelines:

- 1. The quality or the promise of quality of the applicant's work as a teacher, scholar, or interpreter of the humanities;
- 2. The significance of the contribution that the proposed project will make to thought and knowledge in the applicant's field and to the humanities generally, either directly or through the development of the applicant's knowledge;

- 3. The conception, definition, organization, and description of the proposed project; and
- 4. The likelihood that the applicant will complete the project.

Individuals who have recently received major fellowships or research grants are eligible to apply, and their applications will be given serious consideration. However, preference is given to persons who have not been awarded major fellowships or other leave-providing grants, except sabbaticals or grants from their own institutions, for the academic year 1979-80 or any later year. The more recent the grant, the more heavily it weighs in the Endowment's decision. Nevertheless, in particular instances the Endowment may find the merits of an application sufficiently compelling to justify an exception.

Eligibility

An applicant for an Endowment Fellowship should be a U.S. citizen, a native resident of a U.S. territorial possession, or a foreign national who has been residing in the United States or its territories for at least the three years immediately preceding the application deadline.

Although applicants need not have advanced degrees, those whose professional training includes a degree program must have received their degrees, or completed all official requirements for them, by June 1, 1984. If a prospective applicant has completed all of the official requirements for the degree and is awaiting only the formal award, certification that all requirements have been met by the application deadline must be submitted by the dean of the school awarding the degree. Persons seeking support for work leading toward degrees are not eligible to apply, nor are active candidates for degrees, even if they expect to have finished all work for their degree by the time they would begin tenure of the fellowship and the work proposed is not related to their degree program.

For applicants to the program of Fellowships for College Teachers and applicants for Constitutional Fellowships under that program: An applicant should be teaching, full-time or parttime, in a two-year, four-year, or five-year college or university. Faculty members of departments with doctoral programs are not eligible to apply in this program nor are faculty members of postgraduate professional schools. Faculty members of departments that do not grant a Ph.D. within a university that grants the Ph.D. in other fields of the humanities are eligible to apply in this program, but such applicants have lower priority. Retired members of undergraduate institutions are eligible to apply for support in this program, as are college teachers on terminating contracts.

For applicants to the program of Fellowships for Independent Study and Research and for Constitutional Fellowships under that program: Any applicant for a fellowship not meeting the criteria listed above for Fellowships for College Teachers should apply to the program of Fellowships for Independent Study and Research. Therefore, eligible applicants include members of institutions which offer Ph.D. programs in the humanities and scholars with other than academic affiliation or with no institutional affiliation.

Stipends, Tenure, and Conditions of Award

Fellowships normally support full-time work and are awarded for continuous periods of six to twelve full months of tenure. The stipend is intended primarily to replace salary lost through the taking of leave. The maximum amount for a full year or, for teachers, a lesser period that encompasses the full academic year, is \$25,000. The maximum for lesser periods is prorated by months or, for teachers, by academic-year terms. For example, the maximum stipend for a fellowship encompassing two academic-year quarters is \$16,667; for one encompassing a semester, \$12,500; and for one encompassing one quarter, \$8,333. Summer terms

are excluded from consideration in calculating stipends although Fellows may elect to include summer months in their tenure periods. Stipends for 1985-86 will match Fellows' 1984-85 salaries, minus sabbaticals and other grants, up to the maximum stipend level for the tenure period involved. Some assistance may also be provided within the stipend limit to help defray the costs of necessary travel, but no allowance is given for any other expenses.

Fellows may supplement their awards with small grants from other sources, but may not hold other major fellowships or grants during fellowship tenure, except sabbaticals and grants from their own institutions. Successful applicants who receive offers of fellowships from other foundations after submitting their applications to the Endowment must hold the Endowment fellowship first.

Fellows may begin tenure of their awards any time between January I. 1985, and the beginning of the spring term of the 1985-86 academic year. For teachers, tenure periods must include at least one term of the academic year and may not begin or end in the middle of a term of the academic year.

Part-time fellowships, defined as any amount of released time between half time and full time, will be awarded only if exceptional circumstances justify a relaxation of the normal tenure schedule described above. Such exceptional circumstances might entail job responsibilities that cannot be relinquished or arise from the value that teaching a particular course would have for the work proposed for the fellowship, and must be explained in the application. Tenure must be for a continuous period of whole months. The minimum is six months; the maximum is the equivalent of twelve months of full-time tenure: e.g., twenty-four

months at half time; eighteen months at three-quarters time; and sixteen months at two-thirds time. Stipends for part-time fellowships are intended primarily to replace salary lost through released time and will be calculated according to the same principles as those for full-time fellowships. The maximum stipend is \$25,000 and will be prorated according to both the number of terms covered by the grant period and the amount of released time taken. For example, the maximum stipend for a six-month fellowship at half time is \$6,250; for a twelve-month fellowship at three-quarters time, \$18,750; and for a twenty-four month fellowship at half time, \$25,000.

A full-time Fellow must devote full time to the fellowship study and may not accept a teaching assignment or undertake any other major activity during the tenure of the fellowship. A part-time Fellow must devote the entire released time indicated to the fellowship study and may not undertake any other major activity or accept any teaching assignment other than that finally agreed upon between the Endowment and the Fellow.

Application Deadline and Award Notification

Applications must be postmarked by June 1, 1984. Awards will be announced by mid-December 1984.

Application Instructions

A completed application consists of the following materials:

- 1) The original proposal, which includes
 - a) the one-page NEH application cover sheet,
 - b) a curriculum vitae, and
 - a detailed description of the proposed study and brief bibliography, which together should be no longer than five single-spaced pages;
- 2) Eight collated copies of the application cover sheet, *curriculum vitae*, and description of study with bibliography;
- 3) The set of data cards, one $5'' \times 8''$ and one $3'' \times 5''$; and
- 4) Three letters of recommendation, to be submitted separately by the referees on reference-letter forms.

The application cover sheet begins at p. 15, and the reference letter forms follow. The data cards are located on the inside back cover of this brochure.

Applicants should make and keep an additional copy of their applications for their own records.

NEH Application Cover Sheet. Instructions for completing the cover sheet are found on page 16 opposite the cover sheet.

Curriculum Vitae. The *curriculum vitae* should be in concise, outline form and should include the following information:

a) The applicant's status as either a *junior scholar* or *senior scholar*. For purposes of the application, junior scholars hold the rank of instructor or assistant professor in colleges or universities or are at comparably early stages of their careers. Senior scholars are associate professors and full professors or are at comparably mature stages

of their careers. An applicant should also be sure to indicate that he or she is a junior or senior scholar on the reference letter forms and on the $5'' \times 8''$ data card.

- b) A record of the applicant's education, including the titles of any theses or dissertations, and the dates when degrees were awarded. Please note that applicants must have completed their professional training by June 1, 1984. Individuals pursuing degrees may not apply for NEH Fellowships.
- c) A record of employment. If a current contract is ending, the applicant should indicate the date of termination.
- d) A list of the most important academic honors or awards received. The list should include the source, length of tenure, dollar amount, and nature of any fellowship or grant that has been awarded during academic year 1979-80 or any later years, whether it is small or large. In the case of grants held for study and research, the terms of leave provided by the grant should be indicated; in the case of grants awarded for other purposes, the nature of the applicant's involvement and activities should be explained. If applicants have been awarded no grants for tenure in 1979-80 or later years, they should state that none have been received.
- e) A list of major or most relevant publications, if any. Applicants *should not* submit books, articles, or similar materials as supplements to the application.
- f) A list of the names and positions of the three people who will be submitting reference letter forms

Description of Proposed Study. The proposal for a fellowship is the only demonstration that panelists will have of the substance of the project, of the contribution it can make, and of the general quality of the proposed work. It is essential that the

text include enough detail about the ideas, objectives, and methods entailed in the project to enable panelists to assess quality, significance, and feasibility: A simple statement of need or intent is insufficient evidence that a project merits support.

Some reviewers will not possess specialized knowledge of the proposed field of study; therefore, the description should be free of jargon and, as much as possible, technical terms.

Although no particular form is prescribed, the description of the project should address the questions listed below. The text, together with the bibliography, should not exceed five single-spaced pages.

a) What are the basic ideas, problems, texts, or questions the study will examine; what is the planned approach or line of thought, to the extent that it has been developed?

If the area is new to the applicant, what are the reasons for working in the field or what interests have led to the new study; what effects will the new study have on the applicant's knowledge of and approach to his or her own field? If the applicant proposes to take formal course work, what are the courses or programs he or she is contemplating taking and how will they contribute to the applicant's larger objectives?

b) What is the current state of the proposed study: is it in the beginning stages or in progress; what are the plans for each stage; and how does the part of the study to be done under the fellowship fit into the whole? There should be a proposed schedule or plan of work which the applicant would follow during the tenure of the fellowship.

- c) For what audience are the results of the study intended, such as students, other teachers, other scholars, the general public, or some combination of these; and what form is the proposed study likely to assume, such as a book, monograph, text, article, series of lectures, etc.? Has a publisher expressed interest in or awarded a contract for the work?
- d) What is the relationship between the proposed study and the applicant's long-range teaching or scholarly objectives, or to the applicant's development as a teacher, scholar, or interpreter of the humanities?
- e) What contribution is the proposed study likely to make to the field of study, or to teaching and learning in the humanities generally? If the applicant is working in a new area, how will enhancing the applicant's knowledge contribute to his or her audience's understanding of the issues concerned?
- f) What is the relationship between the proposed work and the work of others in the same field; what is distinct about the proposed study?
- g) What is the applicant's competence in any languages needed for the study?
- h) Where will the applicant conduct the study? What is the likelihood of access to archives, collections, or institutions with resources necessary for the work?
- i) If the applicant is applying for a part-time fellowship, what is the necessity of holding the fellowship part-time rather than full-time? For example, what are the job responsibilities that cannot be relinquished or what value would teaching a given course or seminar have on the fellowship project? How much released time,

- between half time and full time, would be devoted to the fellowship; what duties would be relinquished and what duties would be retained during the requested period of fellowship tenure?
- j) If the applicant is to be connected during the period of tenure requested for the fellowship with any other project supported or under consideration by the Endowment, how would the proposed fellowship work fit in with the other project?

Bibliography. Following the text of the project description should be a selected list, which normally should not exceed one page, of publications by other scholars and writers or of sources that the applicant has used or is planning to use that have the greatest relevance to the proposed study. This list of readings and materials is vital to the proposal, for panelists gather from it the amount of work or preparation an applicant has done in the field, the character of the applicant's interests, and the nature of his or her approach.

Reference Letters. Referees should be persons who are thoroughly familiar with the applicant's professional capabilities and accomplishments as well as with the area or areas of the proposed study. Referees should be in a position to discuss specifically the likely results or outcome of the proposed project, its significance to the field and to its intended audience, the general quality of the applicant's work, and the applicant's ability to carry out the project successfully.

For applicants to the program of Fellowships for College Teachers: One of the referees should be a person well acquainted with the applicant's abilities as a teacher, scholar, or interpreter of the humanities to the public and who can speak of the applicant's contribution to learning and teaching in his or her institution: a colleague, the department chairman, or the dean or president of the college. However, it is desirable that not all of the referees be from the applicant's own institution.

For applicants to the program of Fellowships for Independent Study and Research: It is desirable that no more than one referee be from the applicant's own institution.

It is the applicant's responsibility to complete the top part of the reference letter form, to check the appropriate boxes on the front of the form, and to send the form, together with a copy of the application, to each referee. It is also the applicant's responsibility to request referees to send letters of reference directly to the Endowment, addressed to the Division of Fellowships and Seminars. Applicants should ask referees to send reference letters as close to the application deadline as possible.

Submission of Application

The completed application package must be postmarked *no later than June 1, 1984*. The application package should be mailed to the following address:

Constitutional Fellowships

The Application Review Process

The programs of NEH Fellowships have one review cycle a year and receive applications against an annual deadline. Applications to the programs are evaluated competitively by peer review panels. The review process for NEH Fellowships takes six months, and the stages are described below.

Applicants are asked to have reference letters sent to the Endowment in support of their applications. These letters are attached to the applications before they are sent to the panels, and aid panelists as they evaluate applications for awards.

Review panels are assembled by the Division staff and convened at the Endowment. There are no standing panels, and panels are constituted anew for each cycle of applications for the programs. The applications are divided by discipline or clusters of related disciplines into sets for review by panels. There are generally five to seven members on each panel who are familiar with the subject matter of the applications assigned to their panel. Panelists' names are published each year in the Endowment's annual report.

Panelists read and prepare written preliminary evaluations of all the applications assigned to their panel, weighing each one both on its own merits and in its relation to other applications under consideration. At the meeting, panelists arrive at a collective recommendation for each application, discussing it to the extent necessary to agree on its standing. Every panel meeting is chaired by a member of the Division's senior staff, whose function is to make sure that the criteria of selection announced in the application guidelines for the programs are adhered to and that questions about Endowment policy are answered.

After applications have been evaluated, the panel recommendations are brought before a committee of the National Council on the Humanities.

The National Council is composed of twenty-six men and women appointed by the President with the consent of the Senate to advise the Chairman of the Endowment on policy and program matters. NEH staff provide the Council members with information about the applications, the recommendations of the panelists, and separate staff recommendations in instances where panelists have failed to reach consensus or where substantial policy questions have been raised. In turn, the National Council forms a recommendation to the Chairman of the Endowment, and the Chairman makes the final decision on the applications. In the vast

majority of cases, the recommendations of the different parties are the same.

Reapplication is always possible, and failure to gain support in one year does not prejudice an applicant's chances for reconsideration in the next. By writing to the program officer for the program to which they applied, unsuccessful applicants may obtain details of the panelists' evaluations of their proposals so that they can consider how they might strengthen their proposals if they decide to reapply.

Other Programs of the Division of Fellowships and Seminars

Summer Stipends provide support for faculty members in universities and in two-year and four-year colleges and for others working in the humanities to pursue two consecutive months of full-time study or research. An applicant's project may be one that can be completed during the stipend period, or it may be part of a long-range endeavor. The application deadline for 1985 awards is October 1, 1984.

Summer Seminars for College Teachers provide opportunities to teachers in two-year, four-year, and five-year colleges and universities, and to others who are qualified to do the work of the seminar and make a contribution to it. Participants work under the direction of distinguished scholars and teachers and pursue advanced study and research in their own fields or in other fields related to their interests. The seminars last eight weeks and are held at institutions broadly distributed throughout the country. The application deadline for 1985 seminars is March 1, 1985.

Summer Seminars for Secondary School Teachers provide opportunities for teachers of grades 7 through 12 to work in their areas of interest with distinguished teachers and committed scholars, studying seminal works in the humanities systematically and thoroughly. The seminars last for four, five, or six weeks, depending on the individual seminar, and are held at institutions broadly distributed throughout the country. The application deadline for 1985 seminars is March 1, 1985.

Programs at Historically Black Colleges and Universities. In observation of the 200th anniversary of the U.S. Constitution, the Endowment has established a special competition for Constitutional Fellowships, in conjunction with the two regular fellowship programs described above, to encourage study and research over the whole range of philosophical and historical questions raised by the Constitution and the founding period.

All applications will be judged in accordance with the following criteria:

- 1. The quality or the promise of quality of the applicant's work as a teacher, scholar, or interpreter of the humanities;
- The significance of the contribution that the proposed project will make to thought and knowledge in the applicant's field and to the humanities generally, either directly or through the development of the applicant's knowledge;
- 3. The conception, definition, organization, and description of the proposed project; and
- 4. The likelihood that the applicant will complete the project.
